## PRIMUS has secured financing of more than 250 million euros since the beginning of the year

- Four construction projects in Berlin successfully financed

**Berlin, 16.04.2025.** PRIMUS Immobilien AG, a leading real estate developer with a focus on residential construction in Berlin, has secured financing of more than EUR 250 million for a total of four construction projects in the capital since the beginning of the year. "In a market environment that continues to be tense, it is anything but a matter of course to obtain financing for project developments. It is therefore all the more pleasing that our PRIMUS projects are met with great trust by banks and institutional partners," explains David Neuhoff, CFO of PRIMUS.

The financing partners – HVB/UniCredit, Berliner Sparkasse, DZ HYP and a major German insurance company – are supporting four high-quality project developments with a gross development volume of over EUR 400 million and a gross floor area of more than 70,000 square metres. Three projects are in the highly sought-after rental housing construction, and another includes a hotel or serviced apartment concept, which is already 100 percent pre-let. All projects are being built in particularly sought-after Berlin locations: Prenzlauer Berg, Charlottenburg and Kreuzberg.

The projects are thus fully financed and will be completed as planned in 2027 and 2028. The successful financings are not only proof of the high quality and attractiveness of the financed projects, but also a clear commitment of the financiers to PRIMUS as a first-class partner in the Berlin real estate market.
